

EXPRESSION OF INTEREST FOR PROVISION OF CLEANING SERVICES IN PEMBA

Eni Rovuma Basin B.V. – Mozambique Branch invites interested companies to submit *Expressions of Interest* for Provision of Cleaning services and consumables/Beverages for Company premises in Mozambique – Pemba, below are listed the main services requested:

- Office Cleaning;
- Provision of Cleaning Products, Materials, Equipment and office consumables/Beverages;
- Provision of Full Pest-Control Services including snakes;
- Additional Services or Materials (at reimbursable cost);
- Removal of waste/garbage (except hazardous waste);

SCOPE OF WORK

The Scope of Work consists in the provision by a qualified company (Contractor) of the Cleaning, Office Management, Vending Management (Consumables/Beverages), sites pulverization for Covid-19 and other pandemics, Pest Control including snake control and/or additional Services to **Eni Rovuma Basin B.V.** – **Mozambique Branch in Pemba Facilities** such as Hangar, Yard and Port offices, according to the COMPANY needs.

The requested services are divided into two main categories, Routine and Extra-Routine at Company premises as further detailed below:

- The carrying out of all works necessary for the maintaining in working and safe conditions Services in COMPANY's Offices in relation to the present scope of work;
- The carrying out of Cleaning Services in conformity with the schedule proposed, in COMPANY's Offices;
- Extraordinary cleaning work;
- Office management, cleaning control and office activities;
- Supply of consumables/Beverages;
- Spraying against Covid-19 or other pandemics;
- Pest control services, including snakes;
- Periodical reporting.

All activities above described are to be executed in accordance with Local, COMPANY and international HSE norms for the safeguard of workers' health and safety and Local Labour Law.

CONTRACT DURATION

The Provision of Services will begin in the first quarter of 2025, for a firm period of sixty (60) months plus two (2) optional extensions of twelve (12) months each.

DOCUMENTATION REQUIRED

Companies interested in this invitation may submit their *Expression of Interest* by providing the following documentation:

I. Technical documents:

- a) Description and location of Contractor stores and offices;
- b) Contractor Company Organigram;
- c) Evidence of at least 3 years of experience providing similar SERVICES and references from previous clients;
- d) HSE management system manual or list of documents that evidence alignment with international standards (e.g. ISO 14001; BS 18001 or ISO 45001) and/or evidence of certified HSE management system;
- e) HSE statistics for the last 3 years;
- f) HSE Policies.

II. Administrative documents:

- a) Scanned certified copy of the Commercial Register, name of the Legal Entity and contact person who shall receive the qualification package and other relevant information from Eni Rovuma Basin B.V.;
- b) Financial Statements for the past three years and Annual Report including Balance Sheet, Profit and Loss and Cash Flow statement. These documents must be provided by the Company's Group (if applicable), and also by the Company registered in Mozambique that will conclude the contract;
- c) Registration of the company in Mozambique. If not duly registered, the participant shall indicate whether it would be willing to register promptly and the estimated period for doing so;
- d) Structure of the Company or Group with the list of main shareholders and final beneficiaries (if not listed on any stock exchange);
- e) If the Expression of Interest is to be submitted as a Consortium or Joint Venture (JV), information regarding each member belonging to the Consortium or JV with the respective role/position that each member will take in the potential project. The intention to form a Consortium or JV must be supported by an Agreement or "Memorandum of Understanding" duly signed by each member of the group.
