



## **EXPRESSION OF INTEREST FOR PROVISION OF PROJECT MANAGEMENT SERVICES**

### **SCOPE OF WORK**

Scope of the work is to provide Project Management Services (PMS) necessary to support the project team in the execution follow up in term of: Contract Management, Project Control, HSE, QA/QC, Material Management/Expediting Coordination, Construction coordination/supervision, Installation coordination/supervision, pre-commissioning & Commissioning coordination/supervision, Detailed Engineering follow up, Offices in Paris (France) for COMPANY personnel.

The activities under the Scope of Work will be mostly performed in: France, Malaysia, Indonesia, China, Norway, UK, North Africa.

### **CONTRACT DURATION**

The Provision of Services will provisionally begin in the fourth quarter of 2024, for a period of thirty-six (36) months plus two (2) optional extensions of twelve (12) months each.

- a) Being an Engineering and Project Services Company with proven experience in EPC Project Management, including Engineering (FEED, Detailed Engineering), Project Services, Quality Control and Quality Assurance Services, HSE and Sustainability Services, Electronic Data Management, Construction Management, Site Characterization Supervision, Human Factors Engineering, Compliance with Statutory Regulations and Local Content Requirements, Commissioning and Start Up Services, development of Permits & Consents required for Offshore Projects;
- b) Documented professional references released by international customers for performing similar services in the last 5 years;
- c) Health & Safety Management System (OHSAS 18000 or ISO 45001) and Environmental Management System (ISO 14001) documents proving the company compliance with international standards;
- d) Company's HSE performance including events and incidents in the last three years. Total Recordable Incidents Rate (TRIR) shall be provided;
- e) Quality Management System certifications and/or certificates providing the company compliance with national or international Quality Standards (ISO 9001);

- f) Any other information that will establish that your company can fulfill the scope of work.

## II. Administrative documents:

- a) Scanned certified copy of the Commercial Register, name of the Legal Entity and contact person who shall receive the qualification package and other relevant information from Eni Rovuma Basin B.V.;
- b) Financial Statements for the past three years and Annual Report including Balance Sheet, Profit and Loss and Cash Flow statement. These documents must be provided by the Company's Group (if applicable), and also by the Company registered in Mozambique that will conclude the contract;
- c) Structure of the Company or Group with the list of main shareholders and final beneficiaries (if not listed on any stock exchange);
- d) If the Expression of Interest is to be submitted as a Consortium or Joint Venture (JV), information regarding each member belonging to the Consortium or JV with the respective role/position that each member will take in the potential project. The intention to form a Consortium or JV must be supported by an Agreement or "Memorandum of Understanding" duly signed by each member of the group.
