

EXPRESSION OF INTEREST FOR PROVISION OF ROV AND SUBSEA TOOLING SERVICES

Eni Rovuma Basin B.V., Mozambique Branch, invites interested companies to submit their *Expression of Interest* for the **Provision of ROV and Subsea Tooling Services** to support Eni Rovuma Basin B.V. gas field development activity in Mozambique.

SCOPE OF WORK

The scope of work consists of Provision of ROV and Subsea Tooling Services as detailed below in order to perform the well operations activities for the offshore deepwater project:

- Provide number 2 of ROV WORK CLASS to support drilling & completion deepwater operations.
- Provide subsea tooling services for drilling and completion phase.
- Dedicated logistic base in Pemba area is required.
- Administrative & Operative Management based in Maputo/Pemba.

The development project foresees:

- the drilling, completion, and clean-up of four (4) wells in Mozambique Area 4. The expected spud-in date of the well is in Q3-2025 with possible starting of the completion and well testing operation in **Q4-2025**.
- <u>Plus, the drilling, completion, and clean-up of two (2) **optional** wells in Mozambique <u>Area 4.</u></u>

Contractor MUST open a local branch in country with administrative & operative management based in Maputo and dedicated logistic base in Pemba in due time for the support of the drilling activities.

CONTRACT DURATION

The foreseen contract duration will be of one firm period of three (3) years plus two (2) options of one (1) year each.

DOCUMENTATION REQUIRED

Companies interested in this invitation may submit their Expression of Interest by providing the following mandatory information and documentation:

I. Technical documents:

- a) Provide technical datasheet of the ROV and subsea tooling.
- b) Evidence of adequate base in Pemba area to support well operations.
- c) Relevant references for the previously executed offshore deepwater projects.

II. Administrative documents:

- a) Scanned certified copy of the Commercial Register, name of the Legal Entity and contact person who shall receive the qualification package and other relevant information from Eni Rovuma Basin B.V.;
- b) Financial Statements for the past three years and Annual Report including Balance Sheet, Profit and Loss and Cash Flow statement. These documents must be provided by the Company's Group (if applicable), and also by the Company registered in Mozambique that will conclude the contract.
- c) Registration of the company in Mozambique. If not duly registered, the participant shall indicate whether it would be willing to register promptly and the estimated period for doing so.
- d) Structure of the Company or Group with the list of main shareholders and final beneficiaries (if not listed on any stock exchange).
- e) If the Expression of Interest is to be submitted as a Consortium or Joint Venture (JV), information regarding each member belonging to the Consortium or JV with the respective role/position that each member will take in the potential project. The intention to form a Consortium or JV must be supported by an Agreement or "Memorandum of Understanding" duly signed by each member of the group.
