



## EXPRESSION OF INTEREST FOR HANGAR EXPANSION IN PEMBA

**Eni Rovuma Basin B.V.**, invites interested companies to submit expressions of interest for the **Hangar Expansion in Pemba**, Mozambique, to support gas field development activity in Mozambique.

### SCOPE OF WORK

The scope of work consists in the construction and commissioning of the expanded hangar facility, including related infrastructures and systems located at Pemba airport. Below are listed the main services requested:

1. Build hangar expansion divided in:
  - a. Parking Space for helicopters approximately 33x30 meters
  - b. Offices;
  - c. Passenger terminal approximately 8x30 meters;
2. Pavement of area in front to new hangar approximately 82x35 meters;

### Main activities are but not limited to:

#### 1. Construction Phase:

- **Demolition and Site Preparation:**
  - Demolish any structures or components that interfere with the new construction.
  - Prepare the site for foundation and utilities work.
- **Foundation and Structural Work:**
  - Lay the foundation for the expanded area.
  - Construct the steel framework and roofing for the hangar.
- **Interior Systems and Equipment:**
  - Install electrical systems (server room, internet cabling, power, lighting, etc.), HVAC, and plumbing.
- **Fire Safety Systems:** Install fire suppression systems.
- **Utility Connections:** Ensure connection to necessary utilities, such as electricity, water, and gas.

#### 2. Post-Construction Phase:

- **Inspection and Certification:**
  - Conduct inspections to ensure that all work meets aviation, safety, and local building standards.
  - Obtain necessary certifications and approvals from regulatory authorities.

- **Commissioning and Handover:**
  - Perform testing and commissioning of all installed systems.
  - Provide training to operational staff on new systems and equipment.
  - Deliver as-built drawings, warranties, and maintenance documentation.

### **3. Project Management & Reporting:**

- Progress Reports: Provide regular updates on construction progress, including schedule adherence and budget tracking.
- Risk Management: Identify and mitigate potential risks throughout the project.
- Quality Control: Ensure adherence to quality standards through ongoing inspections and material testing.

### **Timeline**

The tenderer should specify the expected timeline for the completion of key milestones outlined below, **considering that the expected construction phase will start in Q4 2025 and shall be completed maximum by May-June 2026:**

- Site preparation and foundation work.
- Structural completion.
- Systems installation.
- Final inspection and handover.

### **CONTRACT DURATION**

The foreseen contract duration will be of one firm period of one (1) year plus two (2) options of one 6 months each.

### **DOCUMENTATION REQUIRED**

Companies interested in this invitation may submit their *Expression of Interest* by providing, through the below specified link, the following documentations:

#### **I. Technical documents:**

- a) Alvará which attests Contractor's registration in Mozambique duly licensed to undertake civil construction activities;
- b) Location of Contractor's base and office;
- c) Contractor's Company Organigram and the expected number of personnel, category, experience to perform the requested Services;
- d) Evidence of a minimum of 5 years' experience in providing similar Services – to provide the description of similar projects implemented and reference letters from previous clients;
- e) List of equipment to be used to perform the Services;
- f) Relevant licenses required by Mozambican law to perform the services according to the SoW.

- g) HSE Management System Manual or list of documents/procedures evidencing alignment with international standards (e.g. ISO 14001; OHSAS 18001 or ISO 45001) and/or evidence of a certified HSE Management System;
- h) HSE statistics for the last three years;
- i) HSE Policies.

**II. Administrative documents:**

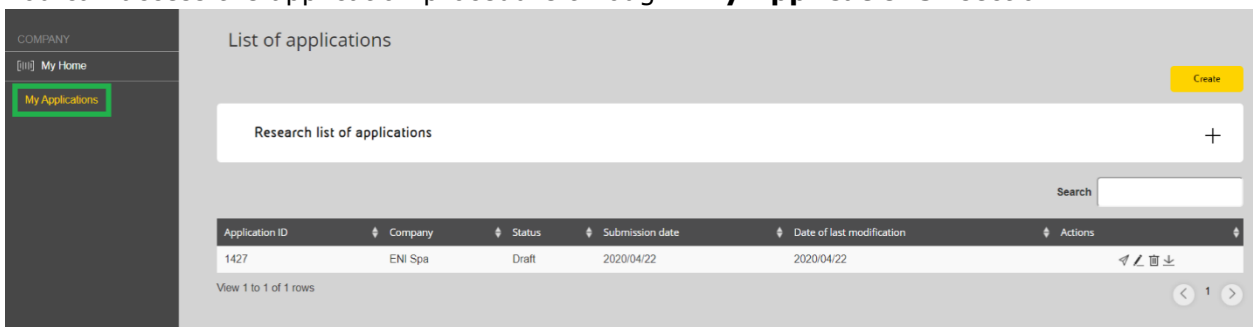
- a) Scanned certified copy of the Commercial Register, name of the Legal Entity and contact person who shall receive the qualification package and other relevant information from Eni Rovuma Basin B.V.;
- b) Financial Statements for the past three years and Annual Report including Balance Sheet, Profit and Loss and Cash Flow statement. These documents must be provided by the Company's Group (if applicable), and also by the Company registered in Mozambique that will execute the contract;
- c) Registration of the company in Mozambique. If not duly registered, the participant shall indicate whether it would be willing to register promptly and the estimated period for doing so;
- d) Structure of the Company or Group with the list of main shareholders and final beneficiaries (if not listed on any stock exchange);
- e) If the Expression of Interest is to be submitted as a Consortium or Joint Venture (JV), information regarding each member belonging to the Consortium or JV with the respective role/position that each member will take in the potential project. The intention to form a Consortium or JV must be supported by an Agreement or "Memorandum of Understanding" duly signed by each member of the group.
