

# EXPRESSION OF INTEREST FOR PROVISION OF LIGHT CONSTRUCTION VESSEL SERVICES

**Eni Rovuma Basin B.V.,** invites interested companies to submit their *Expression of Interest* for the provision of *Light construction Vessel Services* to support gas field development activity in Mozambique.

## **SCOPE OF WORK**

The vessel proposed for the services shall be rated by an approved Classification Society, for subsea construction tasks. The vessel must be available to accommodate Client personnel for the entire duration of the activities.

The Vessel shall operate in a water depth ranging up to 2,500 m and shall comply with the following requirements:

- Heave compensated crane ranging 200-400 Mt capacity to deploy equipment up to 2500 m water depth.
- Nr. 2 work-class ROV systems for subsea installation activities up 2500m WD;
- Deck space ranging 800-1000 m<sup>2</sup>;
- Dynamic Positioning minimum Class DP2.

Services will be required indicatively during the following 2 main windows:

- Q1 2027;
- Q4 2028;

## **DOCUMENTATION REQUIRED**

Companies interested in this invitation may submit their Expression of Interest by providing the following mandatory information and documentation:

### I. Technical documents:

- a) List of potential vessels complying with COMPANY requirement that bidder may propose;
- b) Document of Compliance (DOC) issued under SOLAS 74/78 Chapt.IX, Reg.4 for the type of vessel to be managed; in case DOC is not in the name of the entity wishing to participate to the Expression of Interest, evidence shall be provided of the relationship between such entity and the DOC owner;

- Documented professional references released by international customers for performing similar services in the last 5 years;
- d) Health & Safety Management System (OHSAS 18000 or ISO 45001) and Environmental Management System (ISO 14001) documents proving the company compliance with international standards;
- e) Any other information that will establish that your Company is a capable of fulfilling the scope of work.

## II. Administrative documents:

- a) Scanned certified copy of the Commercial Register, name of the Legal Entity and contact person who shall receive the qualification package and other relevant information from Eni Rovuma Basin B.V.;
- b) Registration of the company in Mozambique. If not duly registered, the participant shall indicate whether it would be willing to register promptly and the estimated period for doing so;
- c) Structure of the Company or Group with the list of main shareholders and final beneficiaries (if not listed on any stock exchange);
- d) If the Expression of Interest is to be submitted as a Consortium or Joint Venture (JV), information regarding each member belonging to the Consortium or JV with the respective role/position that each member will take in the potential project. The intention to form a Consortium or JV must be supported by an Agreement or "Memorandum of Understanding" duly signed by each member of the group.
