



EXPRESSION OF INTEREST FOR PROVISION OF 4 (FOUR) PLATFORM SUPPLY VESSELS (PSV)

Eni Rovuma Basin B.V., invites interested companies to submit their, ***Expression of Interest*** for the provision of **4 (FOUR) PLATFORM SUPPLY VESSELS (PSV)** to support Area 4 offshore activities.

SCOPE OF WORK

The scope of work consists of the provision of **4 (FOUR) PLATFORM SUPPLY VESSELS (PSV)** to support Area 4 offshore activities, in Northern Mozambique, as detailed below.

The PSVs must be fully equipped, certified and able to carry out all typical marine operations and services normally provided by offshore support vessels of this type. The service will be carried out between offshore installations, drilling rigs and other marine units and bases where the vessel can safely lie or operate always afloat, including but not limited to:

- Transport and transfer of typical oilfield goods and materials inclusive of cargo, fuel, fresh water, liquid mud, palletized materials, bulk mud materials dangerous cargoes inclusive of explosive and radioactive sources and oilfield generated waste;
- Stand-by services in assistance of offshore installations;
- Transport industrial personnel;
- Fire-Fighting activity;
- Antipollution services;
- Survivor's management and assistance;
- At least 1 (one) of the PSVs must be capable of accommodating and operating a Level III work-class Remotely Operated Vehicle (ROV).

All permitting, licensing and authorization required to execute the above scope of work shall be arranged by the Contractor with the competent authorities and in full compliance with the legal requirements.

The company must comply with the following technical requirements:

- The vessels must be classified by a recognized Classification Society, a member of the International Association of Classification Societies (*IACS*) and registered with *FLAG ADMINISTRATION on the IMO White List*;
- The vessel's construction year will be from 2010 onwards;
- The vessel shall have a maximum draft of 6.5 m at 75% DWT;
- the vessel shall have a DP2 class rating;
- The vessel shall have a FIFI-1 class rating at least;
- The free area of the deck must be a minimum of 600 m² and the vessel must be equipped with a deck crane of at least 2 tons at 8 m reach;

- The vessel shall be equipped with fuel oil tanks of approximately 1000 m³, and shall be equipped with the following operational tanks:
 - Fuel oil tank;
 - Industrial water tank;
 - Fresh water tank;
 - Dry bulk tanks;
 - Drilling fluid tanks.
- The vessel shall be equipped with life-saving equipment as required by SOLAS 74/78, provided with at least one rescue vessel that meets the requirements of SOLAS Chap. III; Classification class and flag vessel certifications in accordance with international and local standards.
- The main support base will be the port of Pemba.

EXPECTED DATE OF COMMENCEMENT OF THE CONTRACT AND DURATION

The contract is expected to commence in Q3 2026 with an expected firm duration of:

1. 2X PSVs: 60 (sixty) months plus 2 (two) extension options of 24 (twenty-four) months respectively.
2. 2X PSVs: 9 (nine) months, with 2 options of 1 (one) month each.

OPTION

Additionally, the company may request the provision of 1 (one) DP2 vessel to supply and support the platform, with a minimum deck area of 600 m² to made available and ready for operations from May 2028, with an estimated firm duration of 36 months plus 2 (two) extension options of 12 (twelve) months respectively.

DOCUMENTATION REQUIRED

Companies interested in this invitation shall submit their *Expression of Interest* by providing the following mandatory information and documentation:

I. Technical documents:

- a) Proven experience in the provision of Platform Supply Vessels (PSV as operator or manager for Oil and Gas industry;
- b) Fill and sign the Technical Pre-Qualification form of Offshore Vessels Owners, if not yet technically pre-qualified (to be provided duly filled, signed and stamped, upon submission of the technical offer when replying to the ITT);
- c) Document of Compliance (DOC) issued under SOLAS 74/78 Chapt. IX, Reg.4 for the type of vessels to be managed; in case DOC is not in the name of the entity wishing to participate to the Expression of Interest, evidence shall be provided of the relationship between such entity and the DOC owner;
- d) References letters from clients for the previously executed marine operations in support to oil & gas projects; or alternatively, self-declaration signed by the

top management attesting the provision in the past of similar services herein requested;

- e) HSE Management System Manual aligned with international standards (e.g. ISO 14001, OHSAS 18001/ISO 45001) and / or list of HSE documentation related to the SoW activities;
- f) Having Quality Management System certifications and/or certificates proving compliance with international Quality Standards (e.g. ISO 9001:2008);
- g) Company's HSE performance including incidents in the last three years. Total Recordable Incidents Rate (TRIR) shall be provided.

II. Administrative documents:

- a) Scanned certified copy of the Trade Register, Legal Entity name and contact person for receiving qualification package and other relevant information from Eni Rovuma B.V.;
- b) Company's registration in Mozambique. In case your Company is not already registered in Mozambique, please specify if you would be willing to promptly register in Mozambique;
- c) Company and Group Structure with the list of major Shareholders and ultimate beneficiaries (if not listed in the stock exchange);
- d) In case tenderer wish to participate in the Expression of Interest as a consortium, information about each member of the consortium and role of each participant in the consortium. Such intention to form a consortium, must be supported by an agreement or "Memorandum of Understanding" duly signed by each entity member of the proposed consortium.
